**PERINTAH PERKONGSIAN LIABILITI TERHAD (PINDAAN JADUAL PERTAMA) 2022**

LIMITED LIABILITY PARTNERSHIPS ACT 2012

LIMITED LIABILITY PARTNERSHIPS (AMENDMENT OF FIRST SCHEDULE)  
ORDER 2022

IN exercise of the powers conferred by section 92 of the Limited Liability Partnerships Act 2012 [Act 743], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Limited Liability Partnerships (Amendment of First Schedule) Order 2022**.

(2) This Order comes into operation on 1 August 2022.

**Amendment of First Schedule**

2. The Limited Liability Partnerships Act 2012 is amended in the First Schedule, in subparagraph 2(ii), in the column "Governing body", by substituting for the words "Sabah Law Association" the words "Sabah Law Society".
