AKTA PERKONGSIAN LIABILITI TERHAD 2012

ARAHAN MENTERI DI BAWAH PERENGGAN 13(2)(d)

MENURUT subseksyen 13(3) Akta Perkongsian Liabiliti Terhad 2012 [*Akta 743*], Pendaftar menyiarkan dalam Jadual senarai nama perkongsian liabiliti terhad yang Pendaftar telah diarahkan oleh Menteri untuk tidak diterima bagi pendaftaran di bawah perenggan 13(2)(d) Akta.

JADUAL

1. Nama-nama yang membayangkan apa-apa kaitan dengan ahli keluarga diraja atau naungan diraja termasuk nama-nama yang mengandungi perkataan-perkataan seperti “Diraja”, “Raja”, “Permaisuri”, “Putera”, “Puteri”, “Mahkota”, “Raja Muda”, “Yang Mulia” atau “Yang Maha Mulia”
2. Nama-nama yang membayangkan apa-apa kaitan dengan sesuatu jabatan Kerajaan Persekutuan atau Kerajaan Negeri, badan berkanun, pihak berkuasa atau agensi kerajaan atau pihak berkuasa tempatan termasuklah nama-nama yang mengandungi perkataan-perkataan seperti “Persekutuan”, “Negeri” atau “Nasional”
3. Nama-nama yang membayangkan apa-apa kaitan dengan mana-mana kerajaan negara ASEAN, Komanwel atau kerajaan asing, Pertubuhan Bangsa-Bangsa Bersatu atau mana-mana pertubuhan antarabangsa yang lain termasuklah nama-nama yang mengandungi perkataan-perkataan seperti “ASEAN”, “UNESCO”, “NATO”, “EEC” atau “OPEC”
4. Nama-nama yang membayangkan apa-apa kaitan dengan mana-mana parti politik, pertubuhan, kesatuan sekerja, koperasi atau persatuan pembinaan
5. Nama-nama yang termasuk perkataan-perkataan yang berikut atau apa-apa perkataan yang mempunyai maksud yang sama atau seumpamanya:

“Amanah”, “Amanah Saham”, “Bank”, “Bursa”, “Bumiputera”, “Biro”, “Buatan Malaysia”, “Dewan Pengeluaran”, “Dewan Perniagaan dan Perindustrian”, “Eksekutor”, “Harga Patut”, “Institut”, “Insurans”, “Jaminan”, “Jurubank”, “Kewangan”, “Khazanah”, “Kredit”, “Kolej”, “Majlis”, “Pajakan”, “Pejabat Pendaftaran”, “Pelaburan”, “Pengguna”, “Perdana”, “Tauliah”, “Tabung”, “Universiti”, “Urusan Bank”, “Yayasan”

6. Nama-nama yang mengelirukan dari segi identiti, jenis, objek atau tujuan sesuatu perkongsian liabiliti terhad atau yang mengelirukan dengan apa jua cara lain
7. Nama-nama yang mencerca atau yang mungkin dianggap menghina oleh orang awam

LIMITED LIABILITY PARTNERSHIPS ACT 2012

DIRECTIONS OF THE MINISTER UNDER PARAGRAPH 13(2)(d)

PURSUANT to subsection 13(3) of the Limited Liability Partnerships Act 2012 [Act 743], the Registrar publishes in the Schedule the list of names that the Minister has directed the Registrar not to accept for registration under paragraph 13(2)(d) of the Act.

SCHEDULE

1. Names suggesting any connection with a member of the royal family or royal patronage including names containing words such as “Royal”, “King”, “Queen”, “Prince”, “Princess”, “Crown”, “*Raja Muda*”, “*Yang Mulia*” or “*Yang Maha Mulia*”
2. Names suggesting any connection with a Federal Government or State Government department, statutory body, authority or government agency or local authority including names containing words such as “Federal”, “State” or “National”
3. Names suggesting any connection with any ASEAN, Commonwealth or foreign government, the United Nation or any other international organisation including names containing words such as “ASEAN”, “UNESCO”, “NATO”, “EEC” or “OPEC”
4. Names suggesting any connection with any political party, society, trade union, co-operative society or building society
5. Names including the following words or any word which has similar or like meaning:

“Trust”, “Unit Trust”, “Bank”, “Exchange”, “Bumiputera”, “Bureau”, “Made in Malaysia”, “Chamber of Manufacturers”, “Chamber of Commerce and Industry”, “Executor”, “Fair Price”, “Institute”, “Insurance”, “Guarantee”, “Banker”, “Finance”, “Treasury”, “Credit”, “College”, “Council”, “Leasing”, “Registry”, “Investment”, “Consumer”, “Prime”,

“Chartered”, “Fund”, “University”, “Banking”, “Foundation”

6. Names that are misleading as to the identity, nature, objects or purposes of a limited liability partnership or in any other manner
7. Names that are insulting or likely to be considered insulting by the public
